



**TRANSPORTATION SERVICE AGREEMENT BETWEEN  
REGION 10 EDUCATION SERVICE CENTER  
HEAD START PROGRAM  
AND  
TEXOMA AREA PARATRANSIT SYSTEM, INC. (TAPS)**

TAPS and Region 10 Education Service Center Head Start/Early Head Start programs mutually agree to the terms and conditions set forth below:

- 1) TAPS agrees to provide transportation service, as needed, for students attending the Head Start/Early Head Start programs, and parents who are pre-approved by the Region 10 Head Start/Early Head Start staff.
- 2) Transportation service in the city of residence (Grayson County) can be provided as follows:  
\_\_\_\_\_ 7:00 a.m. \_\_\_\_\_ to \_\_\_\_\_ 5:00 p.m. \_\_\_\_\_ each Monday through Friday,  
except on designated holidays.
- 3) Each student in the Head Start/Early Head Start programs will be accompanied by a parent or approved escort.
- 4) TAPS agrees to document trips by students and parents, providing record of the students, parents and number of trips provided on a monthly basis.
- 5) All transportation requests must be scheduled with the TAPS dispatcher at least one day in advance. Standing appointments are available.
- 6) Region 10 Education Service Center and TAPS agree that the charges for services provided under the contract will be as follows:

**ADULT FARE:**


- a. \$2.25 per each scheduled one-way trip within the city of residence, and \$2.25 per each scheduled one-way returned trip, or a total trip charge, per person, of \$4.50.

- b. \$3.25 per each scheduled one-way trip within the county of residence, \$3.25 per each scheduled one-way returned trip, or a total trip charge, per person, of \$6.50.
- c. \$4.25 per each scheduled one-way trip into and adjacent county, and \$4.25 per each scheduled one-way returned trip or a total round trip charge, per person, of \$8.50.
- d. \$4.00 per one-way trip for use of Texoma Express, a connection from Grayson County to DART Rail in Plano, Texas, \$4.00 per each scheduled one-way return trip or a total round trip charge, per person, of \$8.00. Tickets must be bought in advance for services provided by Texoma Express.


**CHILD FARE:**

- a. \$1.25 per each scheduled one-way trip within the city of residence, and \$1.25 per each scheduled one-way returned trip, or a total trip charge, per person, of \$2.50.
- b. \$1.75 per each scheduled one-way trip within the county of residence, \$1.75 per each scheduled one-way returned trip, or a total trip charge, per person, of \$3.50.
- c. \$2.25 per each scheduled one-way trip into and adjacent county, and \$2.25 per each scheduled one-way returned trip or a total round trip charge, per person, of \$4.50.
- d. \$4.00 per one-way trip for use of Texoma Express, a connection from Grayson County to DART Rail in Plano, Texas, \$4.00 per each scheduled one-way return trip or a total round trip charge, per person, of \$8.00. Tickets must be bought in advance for services provided by Texoma Express.

This contract will commence September 1, 2014, and continue through August 31, 2015.
